**CORRIGENDUM TO DIVISION MEMORANDUM NO. 102, SERIES 2020 ON CAPABILITY BUILDING  
FOR PUBLIC SCHOOLS DISTRICT SUPERVISORS (PSDS) ON STRENGTHENING AND  
HARMONIZING INSTRUCTIONAL LEADERSHIP THROUGH GENDER AND DEVELOPMENT

1. In view of the upcoming training on the 2020 National Census for Population and Housing of the Philippine Statistics Authority (PSA) for Census Area Supervisors (CAS) which would be preferably attended by Public Schools District Supervisors, **a change in the priority participants** to the capability building on strengthening and harmonizing instructional leadership through gender and development is imposed.

The same list will be the basis for their travel orders.
3. Participants should be **school heads** and should submit their duly filled up training application form and medical certificate to the BSP, Bohol Council. To qualify further, they must have completed the Basic Training Course (BTC) of any sections of the Boy Scouts of the Philippines.
