1. Pursuant to Deped Order No. 14 s. 2020 otherwise known as the **GUIDELINES ON THE REQUIRED HEALTH STANDARDS IN BASIC EDUCATION OFFICES AND SCHOOLS** which aim to ensure the safety and protection of learners and Deped personnel; thus, this office announces the Distribution of COVID-19 Personal Protective Equipment and advocacy materials for schools.

Daily Travel Expenses (DTE) like per diem and other incidental expenses incurred in the distribution of COVID-19 PPE and advocacy materials shall be charged to DRRM Funds/Division MOOE and for the district level shall be charged to School MOOE/Local Funds subject to the usual accounting and auditing rules and regulations.
