TRAINING OF TRAINERS (TOT) FOR TEACHERS' CAPACITY BUILDING ON THE BASIC CONCEPTS OF GENDER AND DEVELOPMENT (GAD)

- 1. This Office announces the conduct of a 3-day face-to-face Training of Trainers (TOT) for Teachers' Capacity Building on the Basic Concepts of Gender and Development (GAD) on November 17-19, 2020 (Batch 1), November 24-26, 2020 (Batch 2) and December 1-3, 2020 (Batch 3) at Reyna's The Haven and Gardens, Calceta St., Tagbilaran City.
- 2. This Training of Trainers (TOT) is aimed to enhance the competencies of the trainers who will train the newly-hired/untrained teachers on the Basic Concepts of GAD at the District Level/School LAC. DO 43, s. 2017 (The Teacher Induction Program (TIP) Policy) provides that GAD shall be one of the points for discussion in the implementation of the TIP (Session 5 of Module 2 of the TIP). The Beginning Teachers shall be trained to become advocates of the Gender and Development (GAD)-related mandates specifically Republic Act 9710, otherwise known as Magna Carta of Women.
- 3. Participants to this TOT are the following:
 - 1 District GAD Focal Person
 - <u>1</u> Lead Secondary School GAD Focal Person
 2 participants per District
