Pursuant to Administrative Order (AO) No. 27, s, 2012, the Chairperson of the National Historical Commission of the Philippines (NHCP) is directed to lead and implement the program of activities in Commemoration of the 157th Birth Anniversary of Andres Bonifacio on November 30, 2020 and 124th Anniversary of the Martyrdom of Dr. Jose Rizal on December 30, 2020.

All departments, agencies, bureaus, offices, national government agencies (NGAs), local government units (LGUs) and government-owned and controlled corporations (GOCCs) are required to give full support, assistance and cooperation to the National Steering Committee (NSC), chaired by the NHCP in the exercise of its responsibilities and functions to achieve the objectives of abovementioned celebrations.

In support to said commemorations, the Department of Education Central Office (DepEd CO) through the External Partnerships Service shall conduct virtual symposiums on the 157th Birth Anniversary of Andres Bonifacio on

November 25, 2020 and the 124th Anniversary of the Martyrdom of Dr. Jose P. Rizal on December 29, 2020. A National Poster making contest per commemorative event shall be held as part of the celebrations. The contest mechanics and entry form are attached as Annex A and Annex B, respectively. The awarding of winners will be held at the end the symposium.

To further promote the celebrations, Regional Partnerships Focal Persons (RPFs), Araling Panlipunan (AP) and Edukasyon sa Pagpapakatao (EsP) Education Program Supervisors, AP and EsP teachers, and learners are encouraged to host a "Watch Party" of the event on their Facebook accounts. Poster-Making Contest Mechanics

1. Objectives

The poster-making contest aims to increase awareness on the lives, works and heroism of Andres Bonifacio and Dr. Jose P. Rizal, as well as showcase the talents of the Filipino youth through visual arts.

2. Participants

The contest is open to all grades 7-12 students enrolled in any public and private secondary schools nationwide. The school should be duly recognized by the Department of Education. Champions from the previous competitions conducted by the External Partnerships Service – Special Events Unit (EPS-SEU) are disqualified from joining the competition to give chances to others.

3. Scope

The entries should depict the life, works and heroism of Andres Bonifacio/Dr. Jose P. Rizal and how the youth of today can apply Bonifacio's/Rizal's wisdom, compassion, integrity, and love for this country.

4. Entry Specification

Only entries submitted in correct and complete specifications and formats will be considered official. Please take note of the following requirements to ensure that the entry satisfies the specifications of the contest:

- 4.1 The poster should be in a 15"x 12" illustration board.
- 4.2 Contestants may use any medium of their choice.
- 4.3 The poster must be described in one or two sentences. The description must be typewritten and printed on a ½ A4 bond paper. This should be posted at the back of the entry together with the following information:
 - 4.3.1 Name of Learner
 - 4.3.2 Contact Number
 - 4.3.3 School
 - 4.3.4 Division
 - 4.3.5 Region
- 4.4 The Philippine Flag should not be used as background of the painting. If used as part, it should be placed in a conspicuous place to show its importance to the art work (Please refer to Sec. 39 – Prohibited Acts under Republic Act (RA) No. 8491 titled "An Act Prescribing the Code of the National Flag, Anthem, Motto, Coat-of-Arms and Other Heraldic Items and Devices of the Philippines.").

5. Criteria

5.1	Adherence to the Scope and Objective -----	25%
5.2	Creativity and Originality -----	30%
5.3	Composition -----	25%
5.4	Visual Impact -----	20%
	Total -----	100%

6. Determination and Announcement of winners

The contestant who will get the highest score shall be considered as the National Champion, the contestant with second highest score shall be declared as the first runner-up, and the third highest shall be declared as the second runner-up, so on and so forth.

The names of the winners and process on claiming their prizes will be announced during the symposium:

- 6.1 Andres Bonifacio– November 25, 2020/8:00a.m. - 11:00 a.m.
- 6.2 Dr. Jose P. Rizal– December 29, 2020/8:00a.m. - 11:00 a.m.

7. Submission of Entries

- 7.1 The deadlines for the submission of entries are as follows:
 - 7.1.1 Andres Bonifacio – not later than November 19, 2020 at 5:00 p.m.
 - 7.1.2 Dr. Jose P. Rizal – not later than December 21, 2020 at 5:00 p.m.
- 7.2 Each entry must be accompanied by the following requirements:
 - 7.2.1 A certification from the principal that the contestant is enrolled in the current School Year (2020-2021);
 - 7.2.2 Scanned image of the student registration form or ID, principal's ID and accomplished entry form (Annex B)
- 7.3 Entries shall be submitted to:
