The Department of Education, Division of Bohol, through the General Appropriations Act CY 2020 Basic Educational Facilities Fund intends to apply the sum of **Two Million Six Hundred Thirty Seven Thousand One Hundred Eighty Two and 80/100 Pesos (P2,637,182.80) Only** being the Approved Budget for the Contract (ABC) to payments under the contract for the following lots for the project **CY 2020 Basic Educational Facilities Fund Repair of Classrooms of Calabacita NHS, Jagna, Bohol.**

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The Department of Education, Division of Bohol now invites bids for **CY 2020 Basic Educational Facilities Fund Repair of Classrooms of Calabacita NHS, Jagna, Bohol.** Completion of the Works is required to be completed within one hundred fifty (150) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the Department of Education, Division of Bohol and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM during working days.

6. The *Department of Education, Division of Bohol* will hold a Pre-Bid Conference on *November 12, 2020 at nine o'clock in the morning* at the *DepEd-Bohol Division Office Conference Room, New Capitol Site, Tagbilaran City*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *November 24, 2020 at nine o'clock in the morning*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *November 24, 2020 at nine o'clock in the morning* at the *DepEd-Bohol Division Office Conference Room, New Capitol Site, Tagbilaran City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Department of Education, Division of Bohol* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
