Supply and delivery must be done within fifteen (15) calendar days from date receipt of Notice to Proceed and the places of delivery will be at the district offices of the respective elementary school recipients and for the secondary will be direct to the recipient high schools.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Education – Division of Bohol now invites bids for the **Supply and Delivery of Bond Papers for the Reproduction of Quarter 2 Learning Activity Sheets/Modules**. Bidders should have completed, within *five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Department of Education – Division of Bohol and inspect the Bidding Documents at the address given below during office hours (8:00 a.m. to 5:00 p.m.).

5. A complete set of Bidding Documents may be acquired by interested Bidders starting August 6, 2020 from the address below and upon payment of the applicable fee for the Bidding Documents in the amount stated.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPs) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Department of Education – Division of Bohol will hold a Pre-Bid Conference on August 14, 2020 at nine o'clock in the morning (9:00am) at the DepEd-Bohol Division Office Conference Room, New Capitol Site, Tagbilaran City, which shall be open to prospective bidders.
