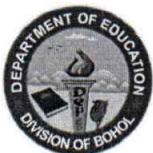

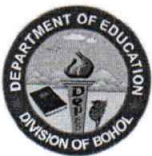

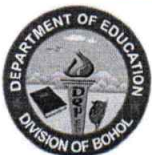

2. The HoPE designates alternate BAC members who shall attend meetings of the BAC and receive the proportionate honoraria, whenever the original members are absent. The alternate members shall have the same term as the regular members.
3. Unless sooner removed for a cause, the members of the BAC and all other committees created shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the Head of Office. Upon expiration of the terms of the current members, they shall continue to exercise their functions until new members are designated.

Procurement Management Unit (PMU), an existing office within the Procuring Entity shall serve concurrently as BAC Secretariat and the Project Monitoring Unit. All existing personnel under PMU shall perform the tasks and responsibilities under the direct supervision of the BAC Secretariat Chairperson Dr. Pablito Villalon.

5. To expedite the procurement process, the members of the BAC, its Secretariat and TWG, shall give utmost priority to BAC assignments over all other duties and responsibilities, until the requirements for the said assignments at hand are completed.
6. The Chairperson of each committee stated herein shall convene regular and special meetings and deliberations and shall provide regular feedback to the Head of Office.
