**CAPACITY BUILDING AND WORKSHOP ON CHILD PROTECTION ON REPORTING  
MECHANISM AND DOCUMENTATION**

**TO: SELECTED DIVISION AND FIELD PERSONNEL**

1. In response to the emerging cases of cybercrime offenses involving teachers and students, there is a need to capacitate school personnel on the legal and technical aspect of cybercrime offenses and social media etiquette in order to protect themselves including their pupils on cybercrime abuses.
2. The continuing classes on blended learning due to the Corona Virus pandemic makes our public school students easy prey on social media predators while that of our teachers as targets of bashing and harassment on different social media platforms.
3. Thus, it is relevant and timely to know the crucial points of reporting mechanisms on such abuses to better equip the teachers of the basics of reporting cases on cybercrime/social media abuses and to further protect our learners from abuse, exploitation from these platforms.
