VIRTUAL IN-SERVICE TRAINING OF TEACHERS (INSET) 2021

- 1. Pursuant to DepEd Order No. 012, s. 2021 entitled "Amendment to DepEd Order 030, s. 2020" dated March 2, 2021, the In-Service Training of Teachers (INSET) will be conducted on March 15-19, 2021. This activity is to be done virtually (virtual INSET) by the use of different technology platforms and with adherence to the IATF health and safety protocols.

- 5. To ensure the participation of the teachers during the online delivery of topics/content by the CO and SDO, the school heads shall strictly monitor their attendance and collect a narrative report (with photo) per session containing their insight to be shared during the school-based INSET.
- 6. This activity will be monitored by the Public Schools District Supervisors. Education Program Supervisors and SGOD Team shall also conduct random monitoring in the three (3) Congressional Districts. It is directed that this is a **school-based activity.** In no way shall it be conducted outside the school premises.
- 7. Expenses relative to the conduct of the INSET such as meals, communication/data allowance (per DM No. 626 and DO No. 38 s. 2020) and travel expenses shall be charged to the School MOOE/SEF/local funds, subject to the usual accounting and auditing rules and regulations.
- 8. Participants can claim reimbursement of Daily Travel Expenses, if they report to other than their respective schools for them to connect/attend the virtual INSET.
- 9. Furthermore, those participants who opted to report at their respective classrooms to attend the virtual INSET may be included for the procurement of meals and snacks from a Philgeps-registered caterer.
- 10. For homebased participants only communication allowance shall be claimed.
- 11. Immediate and wide dissemination of this Memorandum is directed.
