ONLINE SURVEY TO EVALUATE THE IMPLEMENTATION OF THE WEEKLY IRON WITH FOLIC ACID (WIFA) SUPPLEMENTATION IN SECONDARY SCHOOLS

- 1. The Department of Education (DepEd) has been consistent in the implementation of the different health programs to address the health productivity of the learners. One health program implemented is the Weekly Iron With Folic Acid (WIFA) Supplementation among the Secondary School students. Iron Deficiency Anemia (IDA) is one of the major nutritional disorder that needs to be attended. IDA is one of the major causes, as to global statistics, overall death tolls, maternal hemorrhage, reduced school performance and productivity.
- 2. In line with this, DepEd in coordination with the Department of Health (DOH), implemented the WIFA to all secondary female adult learners in all public schools in accordance with DepEd Order No. 59, s. 2017 that bears the policies and guidelines in the said program implementation.

In this regard, all WIFA Program Coordinators are requested to fill-up the Online Survey titled Making Girl Learners Fit For School, Fit For Life: A Program Evaluation Study on the DepED-DOH WIFA Supplementation in Public High Schools.
