**SUBMISSION OF DISTRICT YOUTH FORMATION, SCHOOL YOUTH FORMATION AND
BARKADA KONTRA DROGA (BKD) COORDINATORS' PROFILE**

1. The Schools Division Office of Bohol, Youth Formation Section aims to strengthen the effective implementation of the mandated programs, projects and activities of Youth Formation from the central office down to schools. This call needs the structuring of youth formation organization of the division.
2. To better facilitate the implementation of the different youth formation programs, all Public Schools District Supervisors and School Principals are requested to identify/ designate two (2) District Youth Formation Coordinators/ Focal Persons, one (1) from elementary and one (1) from secondary and Barkada Kontra Droga (BKD) coordinator for every secondary school only. The Supreme Pupil Government (SPG) and Supreme Student Government (SSG) Teacher-Advisers are automatically designated as School Youth Formation Coordinators.
3. The District Youth Formation Coordinators/ Focal Persons to be designated must have the following qualifications: Any teacher-adviser/ career guidance advocate/ master teacher who has at least one (1) year of relevant experience specifically, adviser/ coordinator of the following mandated Programs, Projects and Activities (PPAs) including but not limited to: SPG/ SSG, YES-O, Gulayan sa Paaralan and Barkada Kontra Droga.
4. The District Youth Formation Coordinators will be issued designation by the Schools Division Superintendent, while the school youth formation and BKD coordinators to be endorsed by their respected school heads will be issued by the PSDS.
