2. The identified testing centers are advised to consider the following as part of the health and safety protocols:
 - Permit to conduct the activity from the local IATF/RHU.
 - Foot baths, washing area with soap/alcohol.
 - Holding room/area where examinees would stay before they would proceed to the testing room
 - Isolation room just in case an examinee would have a high temperature.
 - Disinfectants like alcohol to be used for disinfection every after the session.
3. A separate memorandum will be issued by the office for the examinee's specific testing center, date, and time assignment. NO WALK-IN examinees would be entertained during the conduct CB-EPT.
4. Funds for meals and snacks the personnel who would be part in the CB-EPT would be downloaded to the school serving as testing centers, while travelling and other incidental expenses incurred by the personnel relative to the conduct of CB-EPT shall be charged against School MOOE where the personnel came from, subject to the usual auditing rules and regulations.
