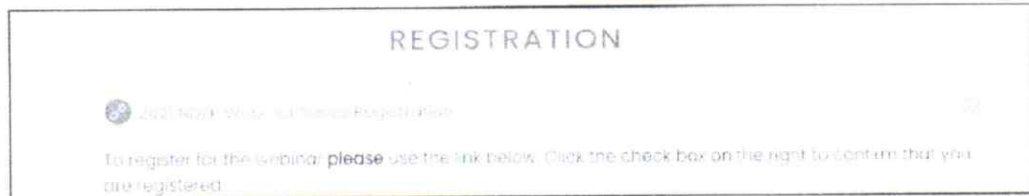




3. After registration, participants may watch the webinars via Facebook Live at the DepEd Philippines Facebook page or through the recording which will be available at the PD-LMS.
