INCESSANT RESPONSE TO THE PREVAILING THREATS OF COVID-19 CASES IN BOHOL DIVISION

To: Assistant Schools Division Superintendents
Chiefs of SGOD and CID
Education Program Supervisors / Education Program Specialists
Public Schools District Supervisors / Acting PSDSs
School Heads / Principals / Head Teachers of Public and Private Schools
All Others Concerned

1. In line with the prevailing **COVID-19 positive cases** in the entire Province of Bohol, including DepEd Division of Bohol, it is critical to continue the suspension of face-to-face activities effective immediately until further notice.
2. This rigorous measure is to prevent mass gathering and to limit physical mobility which impacts the transmissibility of **Severe Acute Respiratory Syndrome Coronavirus 2 (SARS-CoV-2)**.
3. It is highly recommended to use virtual platforms in conducting meetings, seminars and other related programs. Utmost care must be considered in carrying out the End-Of-School Year Rites.
4. On the other hand, previously approved face-to-face activities may proceed provided that **health and safety protocols are strictly implemented (wearing of mask at all times, physical distancing of more than 1 meter and frequent hand disinfection)**. There should be **medics** to monitor the health status and protocols of participants and officials. The body temperature should be taken and health declaration form accomplished upon entering the venue.
5. All requests for approval of activity must be checked by the Medical Officer first prior to issuance of memorandum signed by the SDS. The requirements stipulated in Division Memorandum No. 076, S. 2021, Updated Guidelines for the Requesting of Medics for Approved Limited Face-to-Face activities, must be attached.
