In a study conducted at the Development Academy of the Philippines (DAP), one of the causes of emotional and psychological problems among DepEd teachers and administrators is with regard to slow promotion process. Some of the respondents in the study revealed that they are not aware on the needed documents to support their activities worthy to be part of the considerations in the promotion processes.
