## Subject: HEIGHTENED IMPLEMENTATION OF HEALTH STANDARDS IN BOHOL DIVISION SCHOOLS AND OFFICES

- I. With the recent development of the alarming rise of COVID-19 cases in the Province, this office issues this memorandum to reiterate the strict implementation and compliance to the Required Health Standards in Schools and Offices of the Department of Education, Division of Bohol.
- II. The following preventive standards are reiterated:
  - a) Proper wearing of Face Mask
  - b) Thermal screening and contact logging on arrival at school/office/conference
  - c) Frequent Hand Hygiene and the use of disinfectant foot bath
  - d) Physical Distancing
  - e) Alternative Work Arrangements and other methods that prevent mass gatherings
  - f) Wearing of face shield, especially when in contact with parents/other stake holders/visitors (school/district personnel must wear face shield when transacting at the schools division office).
  - g) Self-disclosure and self-imposed home quarantine when exposed to a confirmed case, and limited movement when exposed to other high-risk individuals
- III. All schools are also reminded on the expedited procurement of triage and disinfection kits as stipulated by Division Memorandum No. 173, s. 2021 or the "Procurement of Triage and Disinfection Kits for the Implementation of the Required Health Standards in Schools". The beneficiary schools are also reminded on the respective liquidation with supporting means of verification (MOVs) of the involved funds.
- IV. Additionally, **limited face-to-face seminars/conferences**, must all adhere to the following conditions prior to their approval and conduct:
