CONFERENCE OF THE DIVISION SCHOOL-BASED FEEDING PROGRAM AND MILK FEEDING COMPONENT CORE GROUP FOR THE S.Y. 2021-2022

- I. DepEd Order 31, s. 2021, or the Operational Guidelines on the Implementation of the School-Based Feeding Program provides direction on the implementation of the School-Based Feeding Program with Milk Feeding Component for School Year 2021-2022.
- II. The same order prescribes that the SDO SBFP Technical Working Group/Core Group shall monitor monthly the compliance of the schools to the guidelines and food distribution.
- III. In view of the issues and concerns gathered by the various monitoring activities conducted by the SBFP TWG/Core Group, and the inputs collected from the conference of the District SBFP Core Group held last February 15 and 16, 2022, this office provides this memorandum to announce the conduct of the Conference of the Division School-Based Feeding Program and Milk Feeding Component Core Group for the S.Y. 2021-2022.
- IV. The activity aims to achieve the following objectives:
 - a. Provide a venue for consultation and coordination among the SDO Core Group and the Milk Supply Partners;
 - b. Discuss and address issues and concerns from the field, especially those observed and documented by the SDO SBFP Core Group during its monitoring activities;
 - c. Plan and prepare for the upcoming implementation of the SBFP Milk Feeding Component for S.Y. 2021-2022.
- V. The Conference of the Division School-Based Feeding Program and Milk Feeding Component Core Group for the S.Y. 2021-2022 will be held at **Bohol Beach Club Resort**, Bolod, Panglao, Bohol on **March 1-2**, 2022.





- VI. Morning snacks will be the first provisions served during day one at the venue and accommodation will be provided to the authorized participants.
- VII. As a means to support this thrust, these are the participants:
 - a. Division SBFP Core Group members
 - b. 1 Representative from the PCC
 - c. 1 Representative from the NDA
- VIII. In compliance to national and local issuances, and the requisite set by the Bohol Interagency Task Force (BIATF) for the approval of the conduct of the activity, **only fully vaccinated individuals are allowed to attend** the conference. Unvaccinated participants or those with COVID-related symptoms will be substituted by an authorized representative. All participants must bring with them their COVID-19 vaccination cards for verification purposes.
- IX. This memorandum serves as a travel order, and travelling and incidental expenses incurred for the attendance of participants and facilitators are chargeable to the MOOE of the sending office or school subject to the usual accounting rules and guidelines.
