

Subject: **CONTINUED SUPPORT AND PARTICIPATION IN THE
SECOND AND SUCCEEDING ROUNDS OF THE NATIONAL
VACCINATION DAYS**

The DepEd Task Force COVID-19 (DTFC) recommends DepEd's continued support for and participation in the second and succeeding rounds of the National Vaccination Days (NVD) as spearheaded and may be announced by the National Task Force against COVID-19 (NTF) and other concerned national agencies. The recommendations in this DTFC memorandum shall apply to the second and succeeding rounds of the NVD, as long as they will entail the participation of DepEd personnel as members of vaccination teams and the use of DepEd schools as vaccination sites.¹

Upon the approval of the Secretary, the offices and personnel concerned shall be expected to comply with the following:

1. Consistent with **DepEd Memorandum No. 082, s. 2021** titled *Bayanihan, Bakunahan National COVID-19 Vaccination Days*, all teaching and non-teaching personnel, parents, and learners from 12 years of age are encouraged to get vaccinated during the NVD, or earlier if possible.
 - a. Personnel who will be vaccinated during the NVD shall not be considered absent from their work, provided that they present proof of vaccination to the heads of functional offices.
 - b. All learners who will be vaccinated during the aforesaid period shall be considered excused from attending classes, provided that they present proof of vaccination to their teachers.

¹ President Rodrigo Duterte officially announced the second round of the National Vaccination Days dubbed as 'Bayanihan Bakunahan,' which is scheduled from December 15 to 17, 2021 (<https://www.facebook.com/utkonv19/posts/444383430557587>). For the National COVID-19 Vaccination Operations Center (NVOC) Advisory No. 119, the NVD of selected regions (Regions V, IV-B, VI, VII, VIII, IX, X, XI, XII, Caraga, and BARMM) have been moved to December 20 to 22, 2021.

- c. Personnel who are parents/guardians of DepEd learners who will accompany their children for pediatric vaccination during the NVD, shall likewise not be considered absent from their work.
- d. Alternative working arrangements may be explored for personnel of schools that will be used as vaccination sites during the NVD.
2. The use of schools as vaccination sites for the NVD and the participation of DepEd personnel during the NVD shall be guided by the applicable recommendations in **DTFC Memorandum No. 566** titled *Updated Recommendations on DepEd's Participation in the National Vaccination Days (Annex A)* as previously approved by the Secretary.

The provisions of **DTFC Memorandum No. 568** titled *Participation in Bakunado Panalo Nationwide Raffle and Sharing of Vaccination Experiences through the DOH Kira Chatbot and on Social Media (Annex C)* that remain relevant for the second and succeeding rounds of the NVD, particularly the demand generation and reporting activities, shall continue to be observed.
- a. All personnel and learners, who have been vaccinated before, during, and after the NVD, are enjoined to provide their feedback about their vaccination experience through the KIRA chatbot of the Department of Health accessible for free at m.me/OfficialDOHgov. A video guide on how to use the platform may be accessed at <https://fb.watch/9zTXqjiGRT/> .



- b. When posting on social media, whether on personal accounts or school/office pages, personnel and learners are encouraged to use the official hashtags #BayanihanBakunahan for posts related to the NVD, #Resbakuna for vaccination experiences before and after the NVD, and DepEd's official hashtags #LigtasNaBalikEskwela and #Vacc2School in all posts. Localized hashtags can also be used by adding the name of the LGU after #Resbakuna (e.g., #ResbakunaManila.)
4. Regional COVID-19 Response/Vaccination Focals are requested to provide reports on the participation of their respective offices, schools, and personnel in the second and succeeding rounds of the NVD using the template annexed to **DTFC Memorandum No. 576** titled *Reporting of DepEd's Participation in the National Vaccination Days* which can also be accessed at <https://bit.ly/nvdreporttemplate>. Reports shall be submitted **seven (7) working days** from the culmination of the NVD through email at blss.shd@deped.gov.ph (cc: pas.cmu@deped.gov.ph) using the subject NVD Report – Region ____ – Round ____.
5. All relevant units and personnel at the DepEd central, regional, and schools division offices to provide necessary support and cooperate as needed with their counterpart units and personnel from agencies involved in the conduct of the NVD and similar initiatives.
