**FINAL CALL ON THE SUBMISSION OF THE SCHOOL-BASED FEEDING
PROGRAM (SBFP) REGULAR COMPONENT FOR SCHOOL YEAR 2021-2022**

1. Pursuant to CSC MC No. 23, s. 2019 entitled "Revised Guidelines on the Settlement of Cash Advance and the Penalty to be Imposed for Failure of an Accountable Officer to Liquidate Cash Advance Within the Prescribed Period" and to various COA Circulars issued, the legal presumption against non-liquidation of cash advance per Article 217 of Revised Penal Code states in unequivocal terms that: "the failure of a public officer to have duly forthcoming any public funds or property with which he is chargeable, upon demand by any duly authorized officer, shall be *prima facie* evidence that he has put such missing funds or property to personal use".

Despite the issuance of Division Memorandum No. 0132, series of 2022 dated March 4, 2022 entitled "Liquidation of the SBFP Regular Component Funds for School Year 2021-2022" which sets the deadline on the submission of the liquidation of such funds (on or before March 15, 2022) and as per records available in this Office, it was noted that there are still 45 schools that were not able to liquidate the SBFP funds downloaded up to date. Attached as **Annex "A"** is the list of schools with unliquidated SBFP funds downloaded.

2. In this connection, this Office issues this memorandum to serve as an **ULTIMATUM** on the submission of the cash advances granted for SBFP Regular Component for SY2021-22. The school head, being the Accountable Officer, is directed to submit the liquidation documents to the District Bookkeeper concerned the soonest time possible. A separate demand letter will be sent to each of the Accountable Officers.
3. Immediate and wide dissemination of this memorandum is hereby directed.
