**ADDITIONAL SUPPORT FUNDS FOR THE SAMPLED SCHOOLS OF DEPED- BOHOL  
ON THE PROGRAMME for INTERNATIONAL STUDENT ASSESSMENT (PISA)**

1. As communicated by the Regional Office of the Department of Education, sampled schools for PISA 2022 will receive an additional amount of Thirty Thousand Pesos ( P30,000.00).
2. The said additional funds shall be used for meals, transportation, health kits, and other PISA-related expenses and shall be subject to the existing government budgeting, accounting, and auditing rules and regulations.
3. All sampled schools are instructed to prepare the Work and Financial Plan (WFP) which must adhere to the approved Breakdown of Estimated Funding Requirements by the Bureau of Education Assessment (BEA) and submit to the Bookkeeper concerned for validation and for PSDS' approval. The approved WFP shall then be forwarded to Mr. Lope S. Hubac – Division Testing Coordinator.
