HRMPSB RESOLUTION NO. 2022-06-001

A RESOLUTION REPEALING DIVISION MEMORANDUM NO. 0275, S. 2022 AND RE-ENFORCING DIVISION MEMORANDUM NO. 0266, S. 2022 WITH THE DEFERMENT OF PARAGRAPH 8, WITH REFERENCE TO THE IMPLEMENTATION EFFECTIVITY OF DEPED ORDER NO. 19, S. 2022 PER DEPED MEMORANDUM NO. 41, S. 2022

WHEREAS, Division Memorandum No. 0266, s. 2022 shall be re-enforced with due reference to DepEd Oder No. 7, 2015 for Kindergarten, Elementary, Junior HS and DepEd Order No. 3, s. 2016 for Senior HS since no new guidelines have been released yet in light of the DepEd MSP per DO No. 019, s. 2022 effectivity of implementation per DepEd Memorandum No. 041, s. 2022 which shall commence on September 01, 2022;

WHEREAS, the Human Resource Merit Promotion and Selection Board (HRMPSB) conveys the Application Process, to wit:

- Old applicants who want to retain their scores must update their pertinent documents in the HRMS-RMS portal to simply include their letter of intent and a copy of the RQA (if available).
- Old applicants who want to update their scores (even if only a section of them) must update their pertinent documents in the HRMS-RMS portal to simply include their letter

of intent (identifying the criteria to be amended), updated documentation, and a copy of the RQA (if available).

c. New applicants, need not do anything;

WHEREAS, Registry of Qualified Applicants (RQA) scores from other divisions resulting from the 2021- 2022 ranking can be used for the ranking entry to be emphasized thru letter of intent;

WHEREAS, to be clear, applicants who took the English Proficiency Test (EPT) in 2021, whether in the Division of Bohol or elsewhere, shall not retake this year due to its two-year validity. For the ranking, equivalent ratings from similar examinations taken from other divisions can be used. Only those applicants who have not yet taken the EPT will be subjected to the scheduled examination;

WHEREAS, the board releases a timetable for the applicants to be guided accordingly:

June 17, 2022	Deadline for updating the pertinent documents by old applicants.
July 11-15, 2022	Online Interview, Assessment of Teaching and Skills Demonstration, and Validation of Documents
To be scheduled...	English Proficiency Test for New Applicants
July 18-22, 2022	Finalization of the Registry of Qualified Applicants
July 27, 2022	Initial Posting of Qualified Applicants for Confirmation and Validation
August 15, 2022	Final Posting of the Registry of Qualified Applicants (Elem)
