She plays a very important role in the implementation of the Girl Scout program, in monitoring and facilitating the membership registration of troops/barangays/district, and the reporting and submission of activities in the district, among other things.

Thus, the need for the DFAs to meet regularly to discuss relevant Girl Scouting activities and problems/issues, submit reports, and register/re-register troops and committees, and so on.

The monthly meeting will be held on a Thursday from 8:00 a.m. to 1:00 p.m. at the Bohol Girl Scout Council Program and Training Center, Tamblot Street, Tagbilaran City on the dates listed below.
