Subject: **ADDENDUM TO DIVISION MEMORANDUM NO. 0517, S. 2022 DOWNLOADING OF ADDITIONAL MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) FUNDS FOR IMPLEMENTATION OF IN-PERSON CLASSES AND COMPLIANCE WITH MINIMUM HEALTH REQUIREMENTS**

1. The principles of minimum health standards being applied in this memorandum has reference to **DepEd Order No. 14, series of 2022** Guidelines on the Required Health Standards in Basic Education Offices and Schools; and, **DepEd Order No. 15, series of 2022** Supplementary Guidelines on Managing Maintenance and Other Operating Expenses Allocation for Schools to Support The Implementation of Basic Education Learning Continuity Plan in Time of COVID-19 Pandemic.
2. The health and safety measures for infection prevention and control in schools and offices adhere to the following objectives: To increase physical and mental resilience; To reduce transmission; To reduce contact; and, to reduce duration of infection.
3. Activities and projects, such as but not limited to the following, are eligible expense items to be charged against the additional MOOE allocation for the Minimum Health Standards:
 - a. Personal Protective Equipments;
 - b. Disinfectants and cleaning detergents;
 - c. Maintenance of respiratory and hand hygiene;
 - d. Provision and/or rehabilitation of water and sanitation facilities;
 - e. Minor improvements in classrooms **for proper ventilation**; and
 - f. Production and distribution of Information, Education and Communication (IEC) materials to promote minimum health standards.
4. Monitoring the compliance with these guidelines shall be conducted by the School Health and Nutrition Section Personnel.
5. For widest dissemination and strict compliance.
