1. Section 36, (b) of RA 9170 re: An Act Providing for the Magna Carta of Women, provides the *“Creation and / or Strengthening of the GAD Focal Point System (GFPS). All departments including their attached agencies, offices, bureaus, state universities, and colleges, government-owned and -controlled corporations, local government units, and other government instrumentalists shall establish or strengthen their GAD Focal Point System or similar GAD mechanism to catalyze and accelerate gender mainstreaming within the agency xxx”*.
