1. The experience of IPED Framework formulation and curriculum contextualization has resulted in specific local arrangements to sustain the dialogue and collaboration between IP communities and DepEd offices. In some areas, IP elders have decided to constitute a core group that would engage DepEd on various program implementation concerns. Such arrangements have so far proven beneficial to the accomplishment of what DepEd, and IP elders have set out to do in curriculum contextualization and addressing emerging program concerns.
2. Based on this experience and considering the growing demand to establish a formal mechanism that would consistently and effectively support the partnership between the DepEd and the IP communities, particularly in curriculum contextualization, efforts have been scaled up and intensified, and the formation of a Consultative and Advisory Body on IPED (CAB-IPED) has been identified as a key measure.
3. Anchored to the above premises, this office, through the office of the Curriculum Implementation Division (CID), will conduct an election of the Consultative Advisory Body (CAB) and a meeting of School Heads of schools implementing IPED on December 9 and 10, 2022 at Reynas Haven and Garden, New Calceta St., Tagbilaran City.
4. Travel and other applicable expenses of IP elders/chieftains will be reimbursed and chargeable against the 2022 IPED Program Support Fund (IPED-PSF), while the school heads' travel will be charged to their school MOOE. All are subject to the usual accounting and auditing rules and regulations.
