 - a. School Profile
 - b. Executive Summary
 - c. Exemplary strategies, projects, or activities relevant to the concerned program conducted/displayed in the last three (3) years
 - d. Impact of the strategies, projects, or activities
 - e. Endorsement letter from the Public Schools District Supervisor
4. Nominations, and the strategies and activities they contain, should be relevant to the aforesaid OKD programs and aligned with the national standards and guidelines set respectively by the Department of Education. Furthermore, submissions shall be pre-screened for those that qualify for validation.
5. Entries shall be **submitted** to the Office of School Health and Nutrition Section at the Schools Division Office **on or before January 25, 2023**.
