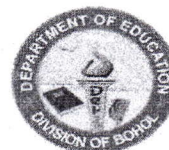

Invitation for Negotiated Procurement

for

Procurement of Technical-Vocational Livelihood Tools and Equipment Packages to Public Senior High Schools for FY 2022 (Negotiated Procurement – Two Failed Biddings)

1. The *Department of Education – Schools Division of Bohol*, through the *Government Appropriations Act CY 2022* intends to apply the sum of ***One Million Five Hundred Six Thousand Eight Hundred Forty Two and 19/100 Pesos (P1,506,842.19) only***; ITB No NP-TFB-2023-02-01, being the total ABC to payments under the contract for the **Procurement of Technical-Vocational Livelihood Tools and Equipment Packages to Public Senior High Schools for FY 2022 (Negotiated Procurement – Two Failed Biddings)**, detailed below.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Department of Education – Schools Division of Bohol** now invites bids for the above Procurement Project. *Delivery of the Goods is required to be completed within **thirty (30) calendar days** from date receipt of Notice to Proceed.* Bidders should have completed, within *five years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through negotiated procurement two failed bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **Department of Education – Schools Division of Bohol** and inspect the Bidding Documents at the address given below from *8:00 a.m. to 5:00 p.m.*
5. A complete set of Bidding Documents may be acquired by interested Bidders on *February 15, 2023 to March 7, 2023.*
6. The **Department of Education – Schools Division of Bohol** will hold a Pre-Bid Conference on *February 23, 2023 at ten o'clock in the morning (Philippine Standard Time)* at the **Department of Education – Schools Division of Bohol (Office of the ASDS/BAC Chairperson), Lino Chatto Drive, Cogon, Tagbilaran City, Bohol** and/or through videoconferencing/webcasting *via any available video conferencing app*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through **manual submission** on or before *March 7, 2023 at nine o'clock in the morning (Philippine Standard Time)*. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on *March 7, 2023 at nine o'clock in the morning (Philippine Standard Time)* at the **Department of Education – Schools Division of Bohol (Office of the ASDS/BAC Chairperson), Lino Chatto Drive, Cogon, Tagbilaran City, Bohol**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Department of Education – Schools Division of Bohol** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to

contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
