1. The Department of Education – Schools Division of Bohol, through the Government Appropriations Act CY 2022 intends to apply the sum of Two Million Eight Hundred Thousand Pesos (P2,800,000.00) only; ITB No G2023-03-02, being the total ABC to payments under the contract for the <u>CONVERSION OF CLASSROOMS INTO</u> <u>INCLUSIVE LEARNING RESOURCE CENTER - Phase 2 (Materials, Tools, Equipment)</u>, detailed below.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The *Department of Education Schools Division of Bohol* now invites bids for the above Procurement Project. *Delivery of the Goods is required to be completed within ninety (90) calendar days from date receipt of Notice to Proceed*. Bidders should have completed, within *five years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from *Department of Education Schools Division of Bohol* and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on March 15, 2023 to April 4, 2023 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00) only. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

Payment for the purchase of the bidding documents can be done at the Cashier's Office of DepEd – Schools Division of Bohol or by depositing the amount in the bank account detailed below:

The *Department of Education Schools Division of Bohol* will hold a Pre-Bid Conference on *March 23, 2023 at nine o'clock in the morning* at the *Department of Education* – *Schools Division of Bohol, 0050 Lino Chatto Drive, Cogon, Tagbilaran City, Bohol* and/or through videoconferencing/webcasting *via any available video conferencing app,* which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through **manual submission** on or before *April 4, 2023 at nine o'clock in the morning (Philippine Standard Time)*. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on *April 4, 2023 at nine o'clock in the morning (Philippine Standard Time* at the *Department of Education Schools Division of Bohol (Office of the ASDS/BAC Chairperson), Lino Chatto Drive, Cogon, Tagbilaran City, Bohol.* Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *Department of Education Schools Division of Bohol* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to

contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
