## CONTINUOUS IMPROVEMENT (CI) PROGRAM DIVISION LEVEL SYMPOSIUM

# To: Schools District Supervisors/Acting PSDSs School Heads All Others Concerned

- In support of DepEd goals and objectives, this office, pursuant to DepED Order 44, series 2015, through the School Governance Operations Division, announces the Cl Program Division Level Symposium on June 30, 2023, and July 1, 2023 at Reyna's the Haven and Gardens, Tagbilaran City.
- 2. This activity intends to achieve the following objectives:
  - 2.1 served as avenue for schools to showcase their CI experience and how the identified solution implemented following the CI process addressed performance issues and gaps.
  - 2.2 led schools, coaches, and trainers to track achievements, and best CI practices.
  - 2.3 allowed schools to replicate promising practices of CI teams and effective CI projects. applicable in their contexts.
  - 3. The schools to participate in the division symposium are the teams of the three CI projects from each congressional districts that passed documents review standards and onsite validation by the CI Technical Working Group. Schools of the selected CI projects shall be informed through another memorandum.
  - 4. Attached is the list of participants, symposium mechanics, and criteria for selecting the best CI project, best presenter, and booth.
  - 5. All concerned judges, assessors and consolidators are required to attend the Prework on June 29, 2023 at Reynas the Haven and Gardens, Tagbilaran City.
  - 6. Teacher participants are entitled to a service credit while administrators/non-teaching personnel shall have the Compensatory Overtime Credits (COC) pursuant to CSC and DBM Joint Circular No. 2, series 2004, "Non-Monetary Remuneration for Overtime Services rendered".





- 7. Relevant expenses such as travel, food, accommodation, materials, and other incidentals shall be charged against school/division MOOE and other local funds subject to the usual COA auditing rules and guidelines.
- 8. This Memorandum also serves as Travel Order.
