1. **Master in Management Major in Public Administration (MMPA).**
2. **Master in Management Major in Educational Governance (MMEM).**

The above degree programs are designed to equip your middle managers and supervisors for a higher climb in the organizational ladder, at par with what leading Metro Manila universities offer, adopts flexible scheduling, easy to enroll in and costs less.

For Schoolyear 2023-2024, the tuition and miscellaneous fees per Trimester for blended online mode of delivery shall be only P25,500. The students must take a total of three (3) trimesters.

The Total Fees Per Trimester includes all Tuition, Miscellaneous and Other Fees. It also covers blended online, extension and venue fees. But it does not include (a) Comprehensive Review Fees, (b) Comprehensive Examination Fees, (b) Thesis Defense Fees, (c) Graduation Fee.

Our Master in Management program can be finished in a year for non-thesis and a year and half for the thesis program. The Learning Management System is provided by an online platform where classes are delivered virtually through ZOOM and Google Meet.

The programs offered are also delivered on a 12 units/Trimester modular approach where one subject is finished within a month before taking on another subject, that way, students will be focused per subject rather than taking all the subjects at the same time. Classes will start in August 2024. Enrolment is on-going.
