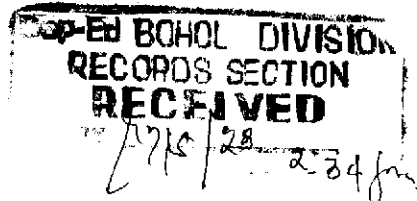



11. Answer should be written only after the question has been read and after the Quizmaster says "GO." A bell will be rung once to signify that the students can now write their answer, and twice at the end of the time limit.
12. Appeals regarding answer to questions may be lodged by the team's adviser/coach only. Appeals or Questions **MAY ONLY BE LODGED IMMEDIATELY AFTER THE QUESTION WAS READ AND THE ANSWER GIVEN.** An appeal process shall consist of the Adviser / coach privately referring the issue to the Panel of Judges. The judges may consult with the opposing coach or Quizmaster as they see fit. It will be helpful if the schools can present sources/references on the issue in question to the Panel of Judges during the appeal process.
13. Decisions of the Panel of Judges shall be final. The official declaration of the outcome of the match shall be irrevocable. The game shall not be replayed, even if the outcome could have been altered by the judgment errors.
14. BITGAP shall choose the members of the Panel of Judges. No member shall come from any school which is currently participating in the contest.
15. The team is expected to arrive at the contest location at least 30 minutes before the match begins. If a team arrives a minute past game time, it automatically forfeits. A team may win by forfeiture.
16. If contest materials are defective, it is the contestant's responsibility to notify the official at once. No adjustment or changes in the match are permitted due to defective or unusable materials.
17. The team dress code for the competition shall comply with the standards set by the school. Team players must wear their school uniform during the competition for easy identification.
18. Nobody is allowed to audio or videotape the proceedings in part or in whole without prior consent of the BITGAP President, who reserves the right to accept or reject any request.
19. Advisers/coaches are responsible for the behavior of their team members. The Panel of Judges can disqualify any team for unruly behavior during the contest.
20. The only time when applause and/or cheering are appropriate is when after the answers have been assessed and the correct answer is given. When a question is read, everybody should remain quiet until the answers have been assessed.

## General Rules and Mechanics

1. The contest features a pair of Grade 10 student players from each of the various high schools in the province.
2. The Annual Provincial Tourism Quiz questions shall include but not limited to subjects on Bohol tourism sites and services, history and heritage, arts and culture and tourism current events. The organizers may also present pictures of tourism sites as part of the contest.
3. The quiz will be held in the City and District Levels.

For the District Level, elimination rounds will be conducted in each district. The top three (3) schools in each elimination round in each of the districts will qualify for the Championship round. The top three (3) schools in each of the elimination rounds should compete in the Championship Round in the City of Tagbilaran.

For the City Level, the elimination round will be conducted immediately before the Championship Round. The top three (3) schools in the elimination round in the City level will qualify for the Championship Round.

4. Teams must be accompanied by at least one teacher adviser/coach. Although the members of the playing team are not required to be coed (male and female), the **Bohol Island Tour Guides Association of the Philippines, Inc. (BITGAP)** encourages schools to field mixed members if possible.
5. If the adviser /coach abandons the team before completion of the contest, the team may be disqualified from the competition.
6. Points are scored by correct answers to the question. There is no subtraction for incorrect answers.
7. Should an answer be interjected from the audience in any form, the question may be discarded at the Judge's discretion with warning for that school where the answer came from and eventually disqualification, if the same school commits the same offense twice.
8. Questions requiring a person's name as an answer may be correctly answered by giving the person's surname only, provided, there are no other person having the same surname with whom he might be confused with (e.g., the Ayala's). If more information is provided than is required for a correct answer and some portion is incorrect, the whole answer will be deemed incorrect. Wrong spelling is wrong.
9. Player substitution is not permitted during the whole duration of the contest. The students who won during the elimination round in the City and District levels must be the ones to compete in the Championship round.
10. Unless indicated otherwise, each team is given (5) seconds to write down their answer/s on the medium provided for the purpose.
