It aims to establish a common understanding of CSE key concepts and messages and to ensure a clear implementation of CSE. The rationale, legal foundation, guiding principles, mechanisms, and procedures are intended to aid teachers, school principals, and other education stakeholders in their efforts to make teaching and learning more relevant, meaningful, and useful to students.
