Participating runners who opt to run for 21k Half Marathon are required to submit an Official FIT-TO-RUN Medical Certificate signed by a licensed physician within two months before the race day.

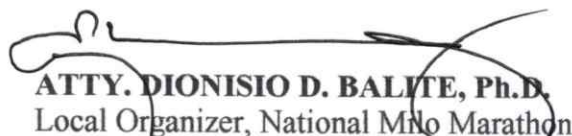

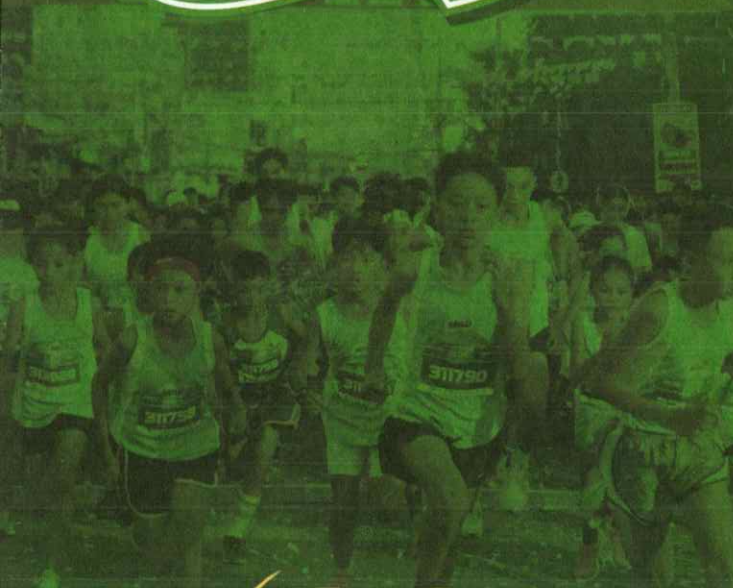

I hereby declare and confirm I am physically fit to participate and take part in the Activity and have no known illness, physical defect, or adverse medical condition that would render me unfit to participate therein. Should I subsequently discover any illness, physical defect, or adverse medical condition that would render me unfit to participate in the Activity, I shall accordingly refrain from participating in said Activity, and I shall immediately advise the Organizer in writing.
3. I hereby authorize the Organizer and/or the Activity sponsor to use my personal information, name, photographs, videos, and/or interviews in connection with the Activity, in broadcast and print media, videotapes, etc. without any consideration, monetary or otherwise.
4. I understand and agree that personal information shall be collected from me by the Organizer and processed for the purpose of organizing and running the Activity I understand that such information may be shared by the Organizer with other third parties who will administer services that are relevant to the foregoing purposes.
5. I understand and agree that my name, home/office contact details, gender, and date of birth will be shared with Nestle Philippines, Inc. (NPI) as the Activity Sponsor for the purpose of: 1) engaging with me as a consumer for all its products and services; 2) sharing information on promotions and events; and 3) marketing activities and communications including third party social networks. If I insist on continuing the race, I hereby acknowledge and agree that I do so of my own volition and risk, and I knowingly and willfully waive and release all rights or claims, if any, that I may have arising from any injury, illness or death that I may suffer, and I hereby hold the organizer and the sponsor, Nestlé Philippines Inc., free and harmless from any liability arising from my said decision to continue with the race.

I hereby declare that I have read and understood this Declaration of Fitness and Waiver and that I have executed this document willingly and voluntarily.
