In line with the Department of Education Regional Office VII's efforts to evaluate and ensure the effectiveness, relevance, and comprehensiveness of the competencies covered in the implementation of the science curriculum, this Office, through the Curriculum and Learning Management Division (CLMD), will conduct the **Learning Competency Audit in Science for Q1 - Q2 on February 12-13, 2025**.

 - a. *assess the implementation of the learning competencies in the science curriculum in Q3-Q4 through analytics, focusing on the least learned competencies and gaps;*
 - b. *identify the interventions and technical assistance provided by the school leaders and division supervisors; and*
 - c. *enhance curriculum implementation by providing insights and recommendations on how well the competencies are being achieved, informing improvements in teaching strategies and learning deliveries.*
