3. The objectives of this training are the following:
 - a) To know and understand the DepEd policies, program and issuances related to Learner's Rights and Protection in order for the participants to be well-equipped and to effectively carry out their respective responsibilities;
 - b) To understand thoroughly the roles and responsibilities of the Child Protection Committee;
 - c) To know and understand the preventive measures in addressing child abuse, exploitation, violence, discrimination, bullying and other acts of abuse;
 - d) To know and understand the protective and corrective measures in addressing child abuse, exploitation, violence, discrimination, bullying, and other acts of abuse;
 - e) To know and understand the social behavioral change strategies for learner protection campaign;
 - f) Overall, to understand the ways and means on how to make CPCs effective, empowered, and functional to effectively ensure protection of learners' rights.
