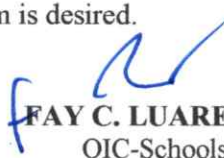

Pursuant to DepEd Memorandum DM-OUOPS-2025-11-00442 dated 20 January 2025 entitled “Learner Government Elections for School Year (S.Y.) 2025-2026”, the Youth Formation Section of the School Governance and Operations Division, hereby informs the field on the conduct of the Division Federated Supreme Elementary and Supreme Secondary Learner Government (SELG/ SSLG) Elections on March 8, 2025 at the Schools Division Office Conference Hall, Tagbilaran City.
2. The SELG/ SSLG elections are pivotal in fostering leadership skills and empowering learners to actively participate in school governance and provide learners with opportunities to assume leadership roles in learner-led clubs and organizations.
3. Participants are the district federated SELG/ SSLG presidents and the Teacher-Advisers as their guardian/ chaperone and are entitled to a one-day service credit. SELG/ SSLG presidents are requested to wear their school ID and respective organization shirts for the activity. Teacher-Adviser are requested to collect/ secure Parent’s Consent. Members of the YFD Technical Working Group will report a day before for the pre-work activity.
4. No registration will be collected from the participants. A packed lunch will be served charged to YFD-PSF funds. Travel and incidental expenses incurred by the participants shall be charged against the school MOOE, SELG and SSLG funds and other available funds subject to the usual accounting and auditing rules and regulations.
