**RESULTS OF THE 2024-2025 CONTINUOUS IMPROVEMENT (CI) PROGRAM
ACTIVITIES**

1. This office, through the Schools Governance Operations Division and Curriculum Implementation Division, announce the results of the 2024-2025 activities of the Continuous Improvement (CI) Program that started in **a.** district onsite validation or symposium, **b.** portfolio assessment of the 58 CI best projects (one in every district), **c.** Onsite validation of the selected 3 best CI projects per congressional district (total of 9) and **d.** deliberation conducted by the division CI TWG to come up with the best 5 CI projects in the Division.
2. It was unanimously decided by the division CI TWG that among the 5 best CI projects, **Loboc National High School's "DIGIMATH: Digital Math Function Challenge"** shall represent the division during the regional Pasidungog competition under the Outstanding Program Implementer category.
3. The other four (4) BEST CI projects in no particular order are the following:
 - Villafuerte ES – Carmen III – WHEEL PRAISED
 - Tupas High School – Antequera – PROJECT TUPAS: Timely Unified Processing of Academic Services
 - Calape National High School – Calape – CSM: Quality Service Through Client Feedback
 - Busalian Elem. School – Talibon 2 – PROJECT ATIK – Atong Tabangan Interedaong Kabataan
4. Congratulations to these schools and districts that showed their best efforts in addressing the schools' PIA's through dedicated implementation of their CI projects.
5. The CI Division TWG, will provide coaching to Loboc National High School CI team on **April 7, 2025, with the following coaches requested to be available: 1. Ester Mingoc, 2. Cerlito Romero, 3. Rachel Briones, 4. Rosanna Dablo, 5. Leah Vanessa Balite, 6. Edgelbert Tesorio.**
6. Relevant expenses incurred by the Division CI TWG members such as travel, food and other incidentals in the conduct of the coaching session shall be charged against school/division MOOE, SEF and other local funds subject to the usual COA auditing rules and guidelines.
