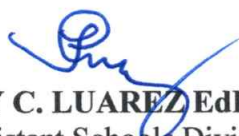

The Manila Teachers' Mutual Aid System, Inc. (MANILA TEACHERS') will hold its 5th Annual Search for Ulirang Guro at Pambansang Ulirang Guro with this year's theme:

***"Guro: Susulong sa Hamon ng Panahon para sa Kalidad ng Edukasyon"***

**I. Introduction**

MANILA TEACHERS' Mutual Aid System, Inc. was founded on October 9, 1975 at General Luna Street, San Agustin, Malabon City, as a mutual benefits association that aims to provide financial assistance to our public school teachers. For almost five decades, MANILA TEACHERS' made a huge difference in the lives of its members and continues to be a bulwark of strength and stability.

In celebration of its 50<sup>th</sup> year, MANILA TEACHERS seeks to honor and recognize teachers who have manifested the values of hard work, dedication, sacrifice, commitment, and perseverance. This exemplifies that teaching is a vocation, not just a profession, that can transform lives.

The search aims to celebrate teachers who have exerted special admirable and herculean efforts in order to teach and educate the Filipino youth. It is not so much about their competencies but rather the sacrifices and the perils he/she has to face, endure and conquer as a teacher.

MANILA TEACHERS' launched its first ever Search for Pambansang Ulirang Guro in 2016, which later became an annual event to celebrate heroic deed of our modern-day heroes, that is, the teachers.

Public school teachers from elementary, junior high, and senior high levels who hold a permanent appointment and have been teaching for at least five years are eligible to join the search.

**II Qualifications:**

The following are the qualifications of a nominee:

1. Must be a Filipino citizen.
2. Must have an average performance rating of "Very Satisfactory" for the past three (3) years.
3. Must not be on leave during the nomination period.
4. Must possess unquestionable integrity.
5. Must not have been suspended or sanctioned for any violation of administrative policies, rules, or regulations.
6. Must have no pending criminal, civil, or administrative case.
7. Must not be the spouse or a first-degree relative of any officer or employee of Manila Teachers'.
8. Must not have received the Outstanding Teachers Award at the national level from any award-giving body (government or non-government) in the past five (5) years.

III. HOW TO JOIN:

1. The nominee must complete the form (ANNEX A) accurately.
2. The nominee must submit an essay of at least 500 words coupled with a documentary video detailing the sacrifices, challenges, and adversities they have faced, overcome, and endured as a teacher, along with how they have positively impacted the lives of their learners.
3. The completed nomination form, video presentation, and other required documents must be submitted to the School Principal for endorsement to the Schools Division Superintendent who in turn will select the best nominee and endorse him or her to the Regional Director.
4. The Regional Director will select the Regional Winner and endorse their nomination to the National Board of Judges at the Manila Teachers' Head Office, located at 918 United Nations Ave, Manila.
5. The **Ulirang Guro** for Southern Luzon, Northern Luzon, National Capital Region (NCR), Visayas and Mindanao will be selected from among the regional winners by the National Board of Judges.
6. The **2025 Pambansang Ulirang Guro** will be chosen from the five (5) winners from Southern Luzon, Northern Luzon, National Capital Region (NCR), Visayas and Mindanao.

V. The SEARCH PROCESS

1. The School Principal/Head endorses the nominee's completed nomination form, written essay, documentary video presentation, and other required documents for the school's Division Superintendent on or before **June 30, 2025.**
2. The Schools Division Superintendent selects and endorses the division nominee to the Regional Director on or before **July 31, 2025.**

3. The Regional Director chooses the best from among those endorsed by the Schools Division Superintendents and endorses him/her to the National Board of Judges on or before **August 29, 2025.**

4. The National Board of Judges at the Manila Teachers' Head Office will choose the *Ulirang Guro* for Southern Luzon, Northern Luzon, National Capital Region (NCR), Visayas and Mindanao among the regional winners on or before **September 16, 2025.**

5. The *Ulirang Guro* for Southern Luzon, Northern Luzon, National Capital Region (NCR), Visayas and Mindanao qualifies to the Search for 2025 Pambansang *Ulirang Guro*.

6. All Regional Awardees, the five *Ulirang Guro*, and the Pambansang *Ulirang Guro* (National Winner) will be invited to the Awarding Ceremony, which will be held on **October 11, 2025**, at a venue to be announced.

## VI. PRIZES

### 1. Pambansang *Ulirang Guro* (1 National Winner)

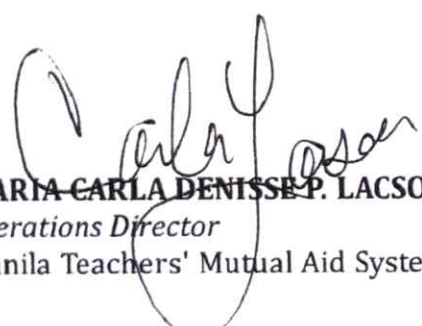
