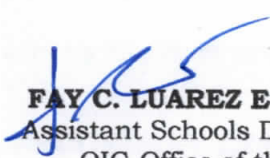

The Basic Education Development Plan (BEDP) 2030, the 5-point Agenda of the Secretary of the Department of Education (DepEd) and the Regional Education Development Plan (REDP) gave emphasis on the holistic development of the learner through the different Learner Formation Programs, Projects, and Activities (PPAs).

6. Moreover, all learner participants are required to submit the signed Parental Waiver and Consent and Learner Consent on or before June 19, 2025. Please refer to the attached template.

7. The first meal to be served to all in-person participants will be lunch on June 20, 2025, while the last meal to be served will be lunch on June 22, 2025. Participants will be accommodated at the DepEd Ecotech Center. Any participant who wishes to leave earlier than the planned closing program is requested to submit a justification letter signed by their SDS.

8. The travel and other incidental expenses of the participants shall be charged to their Local Funds, YFD Program Support Fund, Maintenance and Other Operating Expenses (MOOE) or other fund source/s while meals and accommodation during the conduct of the activity shall be charged against the Regional MOOE under ESSD allocation subject to the usual accounting and auditing rules and regulations.
