**PROGRAM SUPPORT FUNDS FOR THE CONDUCT OF CONGRESSIONAL
DISTRICT FESTIVAL OF TALENTS**

1. With reference to the Division Memorandum 028, s. 2026- GAD Compliant Division Festival of Talents and in line with the Department of Education's thrust to promote learners' holistic development, this Office hereby issues this Memorandum to provide guidance on the utilization of Program Support Funds (PSF) for the conduct of the Congressional District Festival of Talents, which shall serve as a prerequisite activity for the upcoming Division Festival of Talents.
2. The conduct of the Congressional District Festival of Talents seeks to:
 - a. Identify outstanding learners who will represent each Congressional District in the Division Festival of Talents;
 - b. Provide equal opportunities for learners to showcase their talents, skills, creativity, and intellectual abilities;
 - c. Strengthen collaboration among schools and districts in organizing talent-development activities; and
 - d. Ensure the smooth and compliant implementation of Festival of Talents activities through proper fund utilization.
3. a. Program Support Funds may be utilized to defray allowable expenses related to the conduct of the Congressional District Festival of Talents, such as but not limited to:
 - Meals and snacks of participants, officials, and judges
 - Supplies and materials
 - Certificates, medals, trophies
 - Honoraria for the judges
 - Other expenses necessary and incidental to the activity, subject to existing accounting and auditing rules and regulations

b. All expenditures shall be charged against available Program Support Funds amounting to 100,000.00 per host Congressional District and total of 300,000.00 for three Congressional Districts. This amount will be deducted to each school's MOOE fund amounting to 280.00 subject to the usual budgeting, accounting, and liquidation procedures of the Department of Education.
