**DESIGNATION ORDER AS OFFICER-IN-CHARGE OF THE CURRICULUM  
IMPLEMENTATION DIVISION (CID)**

In the interest of public service and to ensure the continuous, effective, and efficient management of the **Curriculum Implementation Division (CID), Schools Division Office of Bohol**, and **pending the appointment of a permanent replacement to the vacated position of CID Chief**, you are hereby **DESIGNATED as OFFICER-IN-CHARGE (OIC), Office of the Chief, Curriculum Implementation Division (CID), SDO Bohol**, effective today January 5-31, 2026.

As Officer-In-Charge of the Office of the Chief, CID, you shall perform the following duties and functions:

- a. Exercise **overall supervision and management** of the Curriculum Implementation Division and its personnel;
- b. Oversee the **planning, implementation, monitoring, and evaluation** of curriculum-related programs, projects, and activities in accordance with DepEd policies and standards;
- c. Ensure the **effective delivery of curriculum support** to schools, learning centers, and field offices;
- d. Coordinate with other division offices, regional office units, school heads, and external stakeholders on curriculum implementation concerns;
- e. Review, endorse, and approve **official communications, reports, and recommendations** related to CID operations, subject to existing rules and delegated authority;
- f. Ensure the proper utilization, safekeeping, and accountability of **government resources, records, and documents** under the CID;
- g. Prepare and submit **periodic accomplishment and status reports** to the Office of the Schools Division Superintendent; and
- h. Perform such other **lawful duties and functions** as may be assigned by higher authority consistent with the functions of the CID.

This designation is **temporary in nature** and shall **not entitle the designee to additional compensation**, unless otherwise authorized by law, rules, or regulations.
