**PROGRAM IMPLEMENTATION REVIEW (PIR) ON SDO BOHOL'S PARTICIPATION TO
THE CENTRAL VISAYAS REGIONAL ATHLETICS ASSOCIATION (CVIRAA) 2026**

To: All Members of the BDSMA

All Others Concerned

1. In line with the commitment of the Department of Education (DepEd) Bohol to continuously improve the delivery and implementation of its programs, projects, and activities, an evaluation of its recent participation in the Central Visayas Regional Athletic Association (CVIRAA) Meet is deemed necessary. Notably, during CVIRAA 2026, the Bohol Delegation sustained its 1st Runner-Up position and recorded a significant increase in its medal haul, from 191 medals in the previous year to 246 medals this year, reflecting the Division's sustained efforts toward excellence in sports development.
2. Relative thereto, a Program Implementation Review (PIR) on SDO Bohol's participation in CVIRAA 2026 will be conducted on May 4-6, 2026, at Bugnaw Si-e, Anda, Bohol. The activity aims to monitor, assess, and evaluate the extent to which program objectives were achieved, and to determine the effectiveness and efficiency of its implementation. The activity will commence at 8:00 am on May 4, 2026 and conclude at 1:00 pm on May 6, 2026.
3. Participants in this activity shall include the Top Management, Representative from the Provincial Government and all members of the Bohol Division Sports Managers Association (BDSMA), who are expected to attend on May 4-6, 2026, and selected members of the CVIRAA Committees, who shall join on May 5-6, 2026.
4. Transportation and applicable DTE relative to its conduct shall be charged against Division/School MOOE, while venue and food shall be charged against **SEF 2026**, subject to the usual accounting and auditing rules and regulations.
5. This memorandum shall serve as your **travel authority**. The full list of participants and their schedule is provided in **ANNEX 2**.
