- 1) The Department of Education – Schools Division of Bohol, through the CY 2025 Government Appropriations Act (GAA) intends to apply the sum Ten Million Two Hundred Fifty Seven Thousand Nine Hundred Forty Four Pesos (**₱10,257,944.00**) being the total Approved Budget for the Contract (ABC) to payments under the contract, **Supply and Delivery of Nutritious Food Products for the School-Based Feeding Program SY 2025-2026 (Secondary Beneficiaries)**, for two (2) lots detailed below:

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- 2) The *Department of Education – Schools Division of Bohol* now invites bids for **Printing, Bookbinding and Delivery of ARAL Reading** as specified in Sections VI (Schedule of Requirements) and VII (Technical Specifications) of the Bidding Documents. Delivery of the Goods is required as specified in Section VI (Schedule of Requirements) of the Bidding Documents. Bidders should have completed, at least **five years** from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR of RA No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4) Interested Bidders may obtain further information from *the Department of Education – Schools Division of Bohol* and inspect the Bidding Documents at the address given below from **8:00 a.m. to 5:00 p.m. from Monday to Thursday, in view of the Office of the President Memorandum Circular No. 114 dated March 6, 2026**
- 5) A complete set of Bidding Documents may be acquired by interested Bidders from *April 16, 2026 to May 7, 2026 from Monday to Thursday, in view of the Office of the President Memorandum Circular No. 114 dated March 6, 2026* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00) for Lot 1 and Ten Thousand Pesos (P10,000.00) for Lot 2.* The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person, by facsimile, or through electronic means.*

Payment for the purchase of the bidding documents can be done at the Cashier's Office of DepEd – Schools Division of Bohol or by depositing the amount in the bank account detailed below:

If payment is done through the bank account detailed above, the prospective bidder is advised to send the e-copy or scanned copy of the deposit slip to **bacdepedbohol@gmail.com** so that the BAC Secretariat can assist the bidder in providing for the Official Receipt of the amount paid.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity,

provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6) The *Department of Education – Schools Division of Bohol* will hold a Pre-Bid Conference on *April 23, 2026 at nine o'clock in the morning* at the *DepEd-Bohol Schools Division Office, 0050 Lino Chatto Drive, Cogon, Tagbilaran City, Bohol* and/or through videoconferencing/ webcasting via any available video conferencing app, which shall be open to prospective bidders.
- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through **manual submission** at the office address indicated below, **on or before May 7, 2026 at nine o'clock in the morning**. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
- 9) Bid opening shall be on **May 7, 2026 at nine o'clock in the morning** at the *DepEd-Bohol Schools Division Office, 0050 Lino Chatto Drive, Cogon, Tagbilaran City, Bohol*. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 10) The *Department of Education – Schools Division of Bohol* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70¹ of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
