**DOWNLOADING OF FY 2025 MADRASAH EDUCATION PROGRAM (MEP)
SUPPORT FUND (CONTINUING) FOR ARABIC LANGUAGE AND ISLAMIC
EDUCATION (ALIVE) IMPLEMENTING SCHOOLS**

1. Pursuant to the provisions of DepEd Order No. 25, s. 2021 (Revised Implementing Guidelines on the Utilization of Fund for Madrasah Education Program), this Office announces the downloading of the Madrasah Education Program Support Fund (Continuing) amounting to One Hundred Thousand Pesos (₱100,000.00) to the schools implementing Arabic Language and Islamic Education (ALIVE) classes.
2. This funding allocation aims to continuously support, strengthen, and sustain the implementation of the ALIVE program, specifically targeting the enhancement of educational opportunities for Muslim learners within their unique cultural and linguistic context.

- Conduct of school-based advocacy activities, orientation, or community mapping for Muslim learners.
 - Operational expenses directly tied to the maintenance of ALIVE classes, classrooms, or learning centers.
 - School-level program monitoring, evaluation, and data updating.
5. The utilization, liquidation, and reporting of the aforementioned funds shall be subject to the usual government accounting and auditing rules and regulations. Recipient School Heads are strictly directed to coordinate with the Division Bookkeepers/Accountants to ensure the swift release and proper liquidation of the funds.
