1. In line with the recruitment and selection process for the position of Public Schools District Supervisor (PSDS) and Principal IV (Elementary), the Recruitment and Selection Process for applicants shall be conducted on **July 8-9, 2026** at **8:00am** at the **Office of Dr. Eduardo A. Ompad**. This activity aims to ensure transparency and proper verification of the documents submitted by applicants. The Behavioral Event Interview and Skills Test for the applicants shall also be conducted during the same schedule.
 2. During the assessment, applicants are required to be personally present while their submitted documents are being reviewed and evaluated by the Committee. This will allow the committee to immediately verify information and clarify any discrepancies or incomplete requirements.
 3. The following guidelines shall be observed during the assessment:
 - a) All applicants must bring their original documents of the required credentials for verification.
 - b) The Committee shall review and validate the documents in the presence of the applicant.
 - c) Any clarification regarding the assessment may be addressed directly to the applicant during the assessment.
 - d) The committee shall ensure fairness, transparency, and confidentiality in handling all applicant information.
