The Girl Scouts of the Philippines (GSP), an inclusive organization for girls and young women, supports the initiative of the National Council on Disability Affairs (NCDA) for Persons with Disabilities (PWDs) pursuant to **Proclamation No. 597 (s. 2024)** issued by the Office of the President of the Philippines, which declares the observation of the **"National Disability Rights Week (NDRW)"** every **17-23 of July**.

The GSP aims to promote inclusivity, respect, and support for the Girl Scouts with special needs and provide a meaningful week of activities that foster friendship, fun, and empowerment among all participants.

With this year's theme **"Rights First, Legislation Forward – Strategic Action for Equal Participation and Inclusive Development"**, all Girl Scout troops in schools are encouraged to actively participate and organize activities throughout the celebratory week. The following are suggested activities:

1. Display a streamer/banner in your classroom/school.
2. Make a post, slogan, and poster about "A Day with the Girl Scouts with Special Needs" on your Facebook account. Use hashtags **#BoholGirlScoutCouncil2026**, **#GSwithSpecialNeeds2026**, and **#NDRW2026**
3. Host an event for Girl Scouts with special needs where you can conduct some games and other activities for them. They can also perform songs/dances or show other talents and recite the "Panata ng Isang Tagapagtaguyod ng Karapatan at Pribilehiyo ng mga May Kapansanan". (*Attachment 1*)
