**DISSEMINATION OF REGIONAL MEMORANDUM NO. 181, S. 2026 RE:
2026 GOVERNMENT CHORALE COMPETITION**

1. Attached is **Regional Memorandum No. 181, s. 2026**, titled "**2026 Government Chorale Competition**," for the information and guidance of all concerned.
2. In line with the said regional memorandum, the Schools Division of Bohol shall send its official delegation composed of selected **DepEd Bohol teaching and non-teaching personnel**, whose names are reflected in the attached list.
3. To ensure quality preparation for the competition, all selected participants are directed to attend the **rigid chorale rehearsals** to be conducted from **July 4 to 7, 2026**, at the **Loboc District Office**. Since the submission of the official entry for the elimination round is scheduled on **July 7, 2026**, all participants are expected to attend the rehearsals consistently and punctually.
4. The teaching and non-teaching personnel included in the official list shall be **granted two (2) days service credits** for the services rendered during the rehearsals conducted on **July 4–5, 2026**, subject to existing DepEd rules and regulations on the grant of service credits.
5. **School Heads of the respective schools of the participating teaching personnel are directed to make the necessary arrangements in the class schedules and instructional assignments to ensure that the learners' classes will continue uninterrupted by assigning qualified substitute teachers or making appropriate teaching adjustments during the rehearsal period. It is expected that the PSDS/APSOS shall closely monitor the classes of the teachers listed herein and ensure that appropriate substitute teachers are available to facilitate their classes during the practice on July 6–7, 2026.**
6. Expenses for transportation, foods, accommodation, and other incidental expenses of the participants shall be charged against the respective **School MOOE/ other local funds**, subject to the usual accounting and auditing rules and regulations. Meanwhile, expenses relative to **costumes, make-up, recording, professional fees of trainers, transportation to the contest venue (if selected in the elimination round) and other related**

competition requirements shall be charged against **Division Funds**, subject to the availability of funds and existing government accounting and auditing policies.
